BUSINESS LICENSE APPLICATION:

This application is for the purpose of assessing and collecting the City of Beaverton Business License fee. The business license fee imposed is for revenue purposes only. The fee shall be in addition to and not in lieu of any other license or permit fee, charge or tax required under any other City of Beaverton code section or ordinance of the City. All businesses operating within the Beaverton City limits must comply with the City's building, zoning, and fire and police safety requirements. The business license required shall not be construed to constitute a permit to engage in any activity prohibited by law nor a waiver of any other regulatory or license requirement imposed by any other provision of City ordinance or federal, state, regional or local law.

DOOR TO DOOR SOLICITATION:

A person who offers goods or services for sale or who solicits money or anything having money value from another person on premises occupied as a residence shall carry a legible copy of a current, valid City business license and produce same for inspection on demand by any person to whom the offer or solicitation is made.

DELINQUENCY CHARGE:

A business license fee due from any person and not paid in full when due is delinquent, and the City may avail itself of any and all remedies available to it to collect the fee from that person, including but not limited to citation of the person for a violation of the Beaverton Code.

A delinquent charge of 10% of the business license fee that is due from any person and is delinquent shall be added to the fee that is otherwise due for each successive 30 day period or portion thereof for which any portion of the amount due, including delinquent charges already imposed, remains unpaid, up to maximum penalty of 100% of the license fee.

PENALTIES:

Violation of the City of Beaverton Business License Ordinance constitutes a Class 2 Civil infraction. Each violation of the provision of the Business License Ordinance constitutes a separate infraction, and each day a violation of the ordinance is committed or permitted to continue constitutes a separate infraction. Penalties imposed under the provision of this ordinance are in addition to the delinquency charge that may be assessed under the provisions of the Business License Ordinance. Penalty for Class 2 Civil Infraction is punishable by a fine of \$150.00 for each infraction.

CODES

- A. AGRICULTURE: Agriculture production, forestry commercial fishing, hunting and trapping and related services.
- B. APARTMENTS: Includes 3 or more dwelling units that are rented or leased.
- C. CONSTRUCTION: Construction (new work, additions, alterations, reconstruction, installations and repairs). Three types of construction are covered: building construction, heavy construction, and construction by other special trade contractors.
- D. MANUFACTURING: In the mechanical or chemical transformation of materials into new products. Also included are firms engaged in assembling component parts of manufactured products.
- E. TRANSPORTATION: Firms providing passenger and freight transportation communications services, or, electricity, gas, steam, water or sanitary services, and all establishments of the United States Postal Service.
- F. WHOLESALE: Businesses engaged in selling merchandise to retailers, to industrial commercial, institutional, farm, construction contractors, or professional business users; or to wholesalers; or acting as agents or brokers.
- G. RETAIL: Selling merchandise for personal or household consumption and rendering services incidental to the sale of goods. Also check the following boxes if appropriate
 Restaurant/Liquor served Restaurant/Liquor not served Tavern
- H. FINANCIAL/REAL ESTATE: Firms in finance, insurance and real estate. Finance includes depository institutions, nondepository credit institutions, holding companies, or other investment companies, brokers and dealers in securities and commodity contracts, security and commodity exchange. Insurance covers carriers of all types of insurance, and insurance agents and brokers. Real estate includes owners, lessors, buyers, sellers agents, and developers of real estate.
