- No counting of participants at the beginning and end of the event either by name or number
- Condition of any bicycle used by any participant in this event, as there will be no safety inspection prior to the event.

I understand that the dangers and risks of participating in this activity may result not only in serious injury, but in a serious impairment of my and my minor child's future ability to earn a living, to engage in other business, social and/or recreational activities, and generally to enjoy life.

In consideration of the City of Beaverton's permission to participate in this event, I for myself/for my minor child named below agree to **WAIVE** any claim for such injury or damage or both that may occur to me and (if a participant) my minor child and to **RELEASE** the City of Beaverton, its elected and appointed officials, officers, employees, and agents from and hold them harmless against any and all claims for injury or damages, except for the sole negligence of the city of Beaverton, that may arise from or in connection with this activity in which I ask to participate.

I hereby agree to accept any risks that maybe associated with Bike Beaverton 2009.
