### **Beaverton Police Officer White's recap**

There were 32 crimes reported in the Vose neighborhood for Dec. 2011. Three officers of the new "Neighborhood Response Team" were introduced. It is hoped that this type of team will be better able to address "neighborhood livability" issues than officers on patrol duty. Two more officers will be added to the team in approximately six months. These officers will cover non-emergent, ongoing, persistent problems that plague residents. Some examples are drug houses, gang tagging, nuisance issues, etc. To report concerns, call the BPD non-emergency #,503-629-0111. Sergeant Mark Groshong was also in attendance tonight and let attendees know that he could be contacted directly about neighborhood livability issues at 503-350-4064.

### **TVFR Recap**

The Farmington Road Firehouse team was present to give an update. They responded to 45 calls last month. Four of those were related to fires. The fire department is usually the first responder for medical calls. This is Heart Month and we were encouraged to not hesitate but call 911 immediately if having problems. Todd Lawrence, volunteer coordinator of Housecall Providers ([tlawrence@housecallproviders.org](mailto:tlawrence@housecallproviders.org)) This agency provides services to homebound individuals with medical issues in the Portland area. Todd asked for suggestions for recruitment of volunteers on the West Side. Training for volunteers is provided and all volunteers go through a criminal record check. The biggest need is for companions who are willing to visit and check in on these people in their homes. Individuals who receive services from Housecall Providers are not billed for this service. If they have medical insurance the agency will bill their insurance company.
