Meeting was called to order at 7 PM by Chairman Jerry Noble.

TVF&R was not present; no report.

Beaverton Police Report by Officer White

In the Vose NAC , January 2012, there was 1 residential burglary, 1 auto theft, 1 arson, 7 vandalisms, 9 narcotics/drugs offenses, 2 DUI's, 2 disorderly conduct, 1 other, and 1 juvenile runaway.

Near Allen Blvd, there has been tagging "Knight Owl". There seems to be more tagging over all. Tagging needs to be covered/cleaned up immediately. He gave a brief explanation of Peer Court. A question came up about RV's and trailers parked overnight on the street while people slept in them. This is illegal.

There is a prescription drug turn in event on Saturday April 28th, 10 AM to 2 PM at City Hall.

There is a free document shredding event on Saturday April 21st at Tektronix on Karl Braun Drive in Beaverton

There is a Car Seat Clinic on Saturday April 28th, 9 AM to 12:30 PM at Beaverton City Hall.

Oregon Legislative Update - Guest Speaker Tobias Read, State Representative

In the house, there are 30 Republicans and 30 Democrats. The budget is a big concern and the state is dependent on income tax.

The Healthcare Transformation Bill passed. This will help with early intervention of health issues. A health insurance exchange for individuals and small business will help with providing a health care system that works for all. Using the service is optional.

The Oregon Education Investment Board has guidelines to hold schools accountable for student achievement. Funding for the school will be based on student achievement.

The Early Learning Council will help with integrating and streamlining of existing early-childhood education programs. Ages 3 to 4 years are some of the most important years of a child's life. Full Day kindergarten will be available in the fall of 2015.

Oregon has new laws regarding foreclosures. Mediation is required prior to Foreclosure. Other options are being put in place to help homeowners. Oregon will help homeowners work with lenders instead of facing "Dual tracking". In Dual Tracking, the homeowner is on one track working with the lender to stay in the home and pay the debt, yet the lender is still proceeding with the foreclosure on another track.

Oregon Economic Development intends to speed dollars into the hands of businesses. Enterprise Zones are set up that will give local government greater flexibility in economic development and growing the economy and jobs. The Oregon Investment Act restructures government, and will attract dollars and combine resources.
