Project Name: **Amendment of Crescent Street Extension Alignment**

Summary of Application: The City is proposing to update the Transportation Element of the Comprehensive Plan to revise Figure 6.4 Functional Classification, Figure 6.5 Action Plan, and Table 6-1 Action Plan. Proposal is for Crescent Street future multimodal street extension to connect to Rose Biggi Avenue, extend west approximately half the current distance toward Cedar Hills Boulevard, then north to connect to Westgate Drive. This street would retain its Collector classification. This request is based on access spacing, distance to the light rail crossing of Cedar Hills Boulevard, and future site redevelopment.

Applicable Location: This amendment would directly apply to properties within the immediate area of east of Cedar Hills Boulevard and south of Westgate Drive.

Applicable Criteria: Comprehensive Plan Section for Amending the Comprehensive Plan: 1.5.1.A-D

To be made a part of the record, correspondence needs to be received by **Wednesday, November 14, 2012**. Please reference the Case File Number and Project Name in your written comments. If you decide to submit written comments or exhibits before the public hearing, all submittals prior to or at the hearing that are more than two (2) letter size pages must include no fewer than ten (10) complete copies of the materials being submitted.

You are receiving this notice to advise you of a proposed ordinance action. Section 50.50.2 of the Beaverton Development Code requires the City to provide written notice of a proposed ordinance action to the applicant, affected Neighborhood Association Committees (NACs), and owners of property within the City for which the proposed ordinance, if adopted, may in the Director's opinion affect the permissible uses of land. Property owner information is based on the most recent property tax assessment roll of the Washington County Department of Assessment and Taxation.

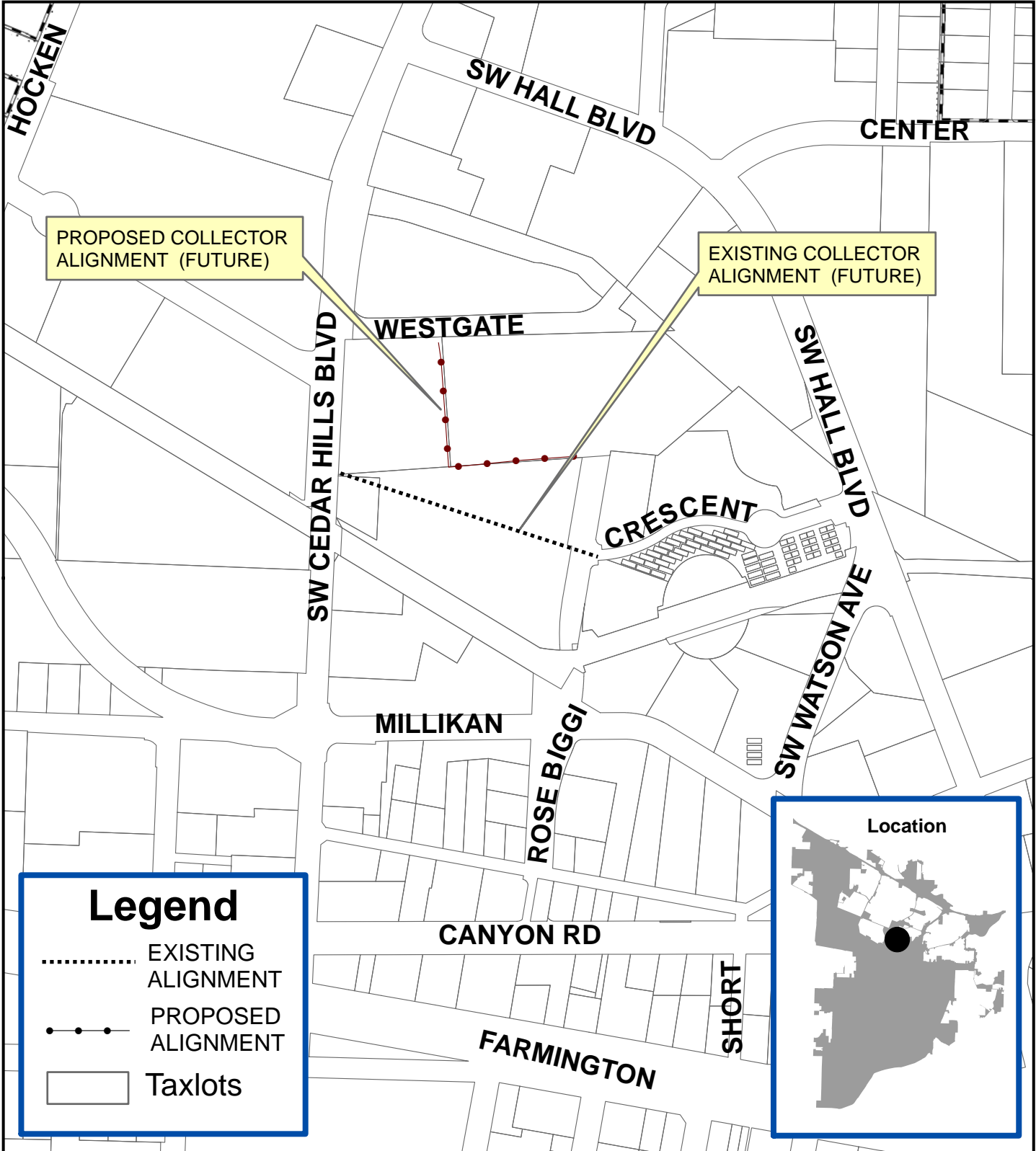
