The meeting was called to order by Henry Kane, Chairman, at 7:00 PM.

Introductions were made.

Tualatin Valley Fire & Rescue (TVF&R) Report

16 new Fire Fighters will be soon joining the ranks. 4 Fire stations are getting remodel and seismic upgrades. The majority of calls received are medical incidents. Paramedics treat heart attack victims. A flyer was made available to “Know The Signs” of cardiac arrest. The heart is a muscle and can deteriorate, call 911 for help.

There were two cars on fire in the area. There was a discussion about apartment buildings of 3 stories or more needing fire sprinklers.

Beaverton Police Report – The officer was not available this evening. Jason Wachs offered to contact the Police Department about a representative attending the meeting in the future.

Neighborhood Concerns and Announcements

Henry announced that on March 6, 2013, Mayor Denny Doyle, will approve the Rapid Flashing Beacon for Safe Street Crossings at Fanno Creek Trail and Hall Boulevard.

February 27, 2013, at 6 PM is the NAC Orientation meeting.

Henry thanked Jason Wachs for taking on the responsibility of arranging to have a trash can placed at the corner of Denny Road and Hall Boulevard.

Henry gave a recap of a past Vose NAC success at stopping the installation of a Hertz Rental facility at the corner of 5th Street and Alger. At that same location the Vose NAC was active in preventing a garbage recycling center from that location. Henry was key, in preventing the Adult Video store, between Beaverton Hillsdale and 5th street from opening 24 hours per day.

Henry updated us on the Oak Hills neighborhood and its historical application.

Discussion - What can the Vose NAC do for the Community?

We discussed obtaining better signage for the NAC, the meetings, the events, and the neighborhood. The Vose NAC has a Facebook page through the city; A volunteer is needed to administer it. (facebook.com\voseneighborhood). There is also a site "Nextdoor", for connecting with neighbors over the internet.

We discussed a project of supplying pet bag dispensers around the neighborhood so owners could clean up after their pets. That led to a discussion about "leash and scoop laws."

New Business

The Matching Fund Grant deadline has been extended until Feb. 25, 2013 per Jason Wachs. There was a discussion about applying for a grant. ***A motion was made to apply for a Matching Fund Grant to cover the cost of food for the August picnic. This was seconded and approved.*** Penny will complete the paperwork and turn it in Monday.
