Meeting was called to order at 7:03 PM, by Henry Kane, Chairman. Welcome and introductions were made.

Beaverton Police Department – Officer Jenkins and Officer Mastripolito reported that there were no major issues during the snow storm. The police pushed a lot of cars out of the ditch. They had to have abandoned cars towed off Hwy 217 because they were blocking the roadway. – Taggers recently hit the area from Allen Blvd. to the Beaverton Transit, and Walker Road to 173rd St., and the area behind Beaverton High School. Some tagging was done in “Texting” and was a little challenging to decipher. The Juvenile Court is reluctant to prosecute unless the taggers are caught in the act.

TVF&R was not available this evening.

Neighborhood Garage Sale Ideas– Cheryl Gill told us about her experiences. She was given the task of organizing a neighborhood street garage sale by the original organizer. Cheryl knocked on doors to discuss the event. She asked for money to finance advertising and signs. She says to ask people what items they will have for the garage sale so they can be highlighted in the advertisement. The number of households should be put in the advertisement. Numbered maps can be created, but not necessary. It would be helpful to get one person on each street to notify and coordinate the event on that particular street. It was discussed that we need to research other events in the city and other neighborhood garage sales before deciding on a date. She thought she had chosen the second weekend in July in the past. She says it is best to have the sale on Friday and Saturday. Flyers can be handed out in the neighborhood and at school. Kristen Bea will check with New Horizons Condo Association, which is in the Vose NAC, to see when they are holding their garage sale.

June handed out information on **Villages NW**. This promotes an Aging-in-Place Village. It helps people age in place, in their own homes, for as long as possible. An informational meeting will be held at the Beaverton City Library on March 1, 2014, at 2 PM. More information can be found at

Kristen recently moved to the Vose neighborhood. She had been the BCCI rep with her previous NAC and is requesting the position of BCCI Rep with Vose NAC. ***A motion was made to nominate Kristen Bea as a board member, and the BCCI alternate Rep. Motion was seconded and passed.***

We still have an opening for a vice chairman, or if preferred the Recorder position, which Penny Douglas currently holds.

Melissa from Central Beaverton NAC told us about the Theatre in the Park, which is held at Schiffler Park in the summer. It is funded through a city grant and a partnership with THPRD. A sound system is needed to provide sound for a large crowd and large area at the park. They also need a larger stage. Melissa is willing to complete the application for a city Grant, from the Vose NAC, to cover the cost of the sound system if the Vose NAC will approve. She assured us that Vose NAC will not have to provide any money and that all of the money will be refunded through the Grant. ***A motion was made to apply for a Matching Fund Grant, not to exceed \$1500, to provide a sound system for Beaverton's Theater in the Park. A motion was made to second, and the motion passed.***

In the past we have discussed doing something for **Vose School**. Penny Douglas called the school and spoke with Stephanie. Penny asked if they needed school supplies or clothes for the clothes closet. Stephanie said they were in desperate need of copier paper. ***A motion was made to donate up to \$100 for copier paper to Vose School. Motion was seconded and passed.*** Penny will purchase and deliver the copier paper to Vose School.

Beaverton City Council – Henry Kane reported that the Council will consider allowing Medical Marijuana Dispensaries within city limits. He says, if it is passed by the Council he will seek to block the approval.

Vose NAC will not be meeting in March. We are invited to attend the Thursday March 20th meeting at the Greenway NAC for the Mayor's City Update. The meeting starts at 7 PM in the Conestoga Middle School Library at 12250 SW Conestoga Drive. The Vose NAC will meet next on April 17, 2014.

Treasurer's Report – Penny Douglas – Checking account balance on 1/31/14 is \$1,714.58.

Approval of minutes from Vose NAC meeting January 16, 2014. – Penny Douglas - ***A motion was made to approve the minutes from the Vose NAC meeting dated 1/16/14. The motion was seconded and passed.***
