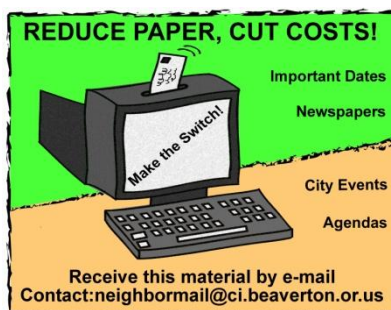

On August 13, 2007, the Planning Commission approved Land Use Orders No. 1999 and 2000 which approved the construction of 9 single family home lots and associated open space tract including other site improvements. This request does not alter the approved Land Division or Conditional Use (PUD) approvals. The Land Division approval would automatically expire on August 13, 2009, however an approved Extension application would allow the decision to remain valid for up to two (2) additional years.</p>
