PACKET A: Arrest but no conviction

Things you will need to complete this process:

- > Forms
- > One Complete Set of Fingerprints
- > Information on Charges Filed and Corresponding Case Number
- > A clear understanding of the law in the matter. Read ORS 137.225 carefully

PRIOR TO FILING

Determine if your arrest is subject to Expungement - Read ORS .137.225(1)(b)

Forms - You may purchase the forms from any office supply store or you may use these forms as examples to file your request. There should be four forms in the packet: The Motion, the Affidavit, the Order, and the Certificate of Service.

You need to complete the forms and have your sig nature notarized on the Affidavit. Do not sign the Affidavit until you are in the presence of a Notary. Complete all the information on the Motion, Affidavit, and Order.

Fingerprints - You will need a complete set of your fingerprints. Finger printing services are available at county law enforcement agencies.

Copies - In addition to the original forms that you will file with the Court, you are required to serve (give) the Beaverton City Attorney's Office (CA) a copy of the Motion, Affidavit and Order that you are filing with the Court. So, when you have completed the forms, make a copy of the Motion, Affidavit and Order. You may wish to make a copy for yourself as you will be filing the original with the Court.

Service on the City Attorney - When you have a complete set of your fingerprints, completed the forms, and made copies, take the City Attorney copies to their office located on the second floor of the Beaverton City Hall Building, 4755 SW Griffith Drive, Beaverton; or you may mail them to: POB 4755, Beaverton, Oregon 97076, attention Beaverton City Attorney's Office. With their copies of the documents, (YOU MUSTINCLUDE YOUR SET OF FINGERPRINTS.)

FILING YOUR PAPERS

Mail or personally file all the original forms with the Beaverton Municipal Court, located at 4755 SW Griffith Drive, (first floor), or by mail to: Beaverton Municipal Court; POB 4755, Beaverton, OR 97076. Make sure that you have completed ALL the blanks on the Motion, Affidavit, and Order. Make sure that you have signed and have had your signature notarized on the Affidavit

WHAT HAPPENS NOW?

The City Attorney (CA) has the right to object to your request to have the records of your arrest set aside. They will send your fingerprints to the Oregon State Police State Identification Bureau to confirm your identity and to see if there have been any other incidents that would cause them to want to object to your request. When the State ID Bureau has completed their investigation, they will send the results back to the CA. The CA will file a Motion with the Court in response to your request. The CA will either object or approve of the set aside. The Court will then decide, based upon the information presented, whether to grant or deny your request If the Court grants your request, a Judge will sign the Order that you submitted. Certified copies will be sent to those agencies that have your arrest records and also to you. The Court will also order the Court's file which contains your request be sealed. If the Court denies your request, a notice will be sent to you advising you that your request was denied.
